

Privacy Policy

This Privacy Policy ("Policy") applies to 2591 Dallas Parkway Suite 300, and Natural Progression Counseling Center, PLLC ("Company") and governs data collection and usage. The Company's website is a Wix site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
